To the fullest extent permitted by law, the Subcontractor hereby acknowledges and agrees that it shall indemnify, hold harmless and defend the General Contractor, the Owner, Architect and Engineer and any of their officers, directors, employees, agents, affiliates, subsidiaries and partners from and against all claims, damages, losses and expenses, including but not limited to, attorney's fees, arising out of or resulting from the performance of the Subcontract's Work under this Subcontract, provided that any such claim, damage, loss or expense (1) is attributable to bodily injury, sickness, disease or death or injury to or destruction of tangible property (other than to the work itself) including loss or use resulting there from, and (2) is caused in whole or part by any acts or omissions of the Subcontractor, its employees, agents

- or sub-subcontractors or anyone directly or indirectly employed by any of them or anyone whose acts any of them may be liable.
- D. The Subcontractor hereby acknowledges its obligation under the foregoing paragraph to indemnify the General Contractor against judgments suffered because of the Subcontractor's work and to assume the cost of defending the General Contractor against claims as described in the forgoing paragraph.
